SCIENTIFIC PROGRAM

Fall/Winter 2013 Meeting

The November 16, 2013 meeting was titled "A Morning of Local Talent." It was a bit different than the format in the past in which we normally do not invite local speakers, but it was definitely worth it.

Louis Aronne, MD began the morning with a lecture on obesity and treatment. He gave a very good lecture on the physiology of obesity and the inter-relationship between adipocytes and hormones. He emphasized that shrinking fat cells was more important than fat excision or liposuction to control these hormones. He discussed interesting theories of how inflammation of the hypothalamus may contribute to obesity. He discussed how low-carb diets and Mediterranean type diets seem to be the best. He also reviewed the current medications available for obese patients and interesting possibilities for the future.

Dr. Perry Robins, a world renowned dermatologist, gave us a lecture on the "Ten Commandments of Dermatologic Surgery." This was a nice presentation from someone who has been in the field for more than 50 years and it was a good history lesson of what worked for him. Just as interesting were the little anecdotes about his interactions with several plastic surgeons that were well known during the Converse years at NYU.

Roy Geronemus, MD gave a lecture reviewing the available laser technology. He reviewed the use of many of these products including his preference for the Thulium 1927nm laser for treatment of AK's and dyschromias, the picosecond laser for tattoos, and the V-beam for early post-surgical or post-treatment bruising.

Babak Mehrara, MD presented the Memorial Sloan Kettering breast reconstruction experience. This past year alone the group performed over 1100 tissue expander reconstructions and almost 130 DIEP flap reconstructions. He reviewed their complication rates and general treatment protocols. He also reviewed their experience with the form-stable silicone breast implants as well as their use of autologous fat transfer for secondary breast deformities.

Dr. Norman Pastorek gave an excellent lecture on his experience using closed rhinoplasty techniques to treat the under projecting nasal tip. In his opinion, this often required suturing techniques along with columella strut placement. He showed many difficult cases with excellent results.

Our final speaker of the day was our Masters Lecturer Dr. Berish Strauch. He reviewed his life in plastic surgery from his days of training with Dr. Chase in Stanford through his position as Chairman of Plastic Surgery at Montefiore Medical Center. It was interesting to see how his career pursuits had changed over the years. All in all a great day.

Our next scientific meeting will be on May 10th. The scientific meeting is titled Periorbital Rejuvenation. The speakers will be Grady Core, MD, Steve Byrd, MD, Jeremy Brauer, MD and Patrick Sullivan, MD.




DONALD WOOD-SMITH, MD

He completed his plastic surgery training at the Institute of Reconstructive Plastic Surgery-NYU Medical Center. Dr. Wood-Smith is professor of Plastic Surgery at New York's Columbia Presbyterian Hospital and Chairman of the Department of Plastic Surgery at the New York Eye & Ear Infirmary. Dr. Wood-Smith is published in over a hundred scientific papers.

LEGISLATIVE UPDATE MARCH 2014

MSSNY held their annual Albany legislative day March 10th, 2014. The usual topics were discussed but for plastic surgeons there are some important issues in the forefront.

Out-of-Network Reimbursement

Our Governor has included in his budget a bill that forces insurance companies to provide out of network (OON) benefits to their subscribers. This used to be standard; you could purchase a policy that allowed you to go out of network. Years ago the fee schedule was determined by the Ingenix Schedule, which was found to be incorrect, as it was developed by the insurance companies. Now we have a new OON reimbursement schedule FAIR Health. However, the insurance companies thought that the FAIR Health reimbursement rates were too high, so they decided to tie their OON benefits to a percentage of Medicare instead.

In New York State, insurance companies have eliminated OON coverage in most new policies. Thus, you need to be an in-network physician to get reimbursement, like it or not. Governor Cuomo has a provision in his budget that would force the insurance companies to offer OON coverage and to tie reimbursement to the FAIR Health fee schedule. Furthermore, the insurance companies would have to make available an option to purchase coverage that covers 70% of "usual and customary" costs of OON.

With the passage of the budget which was done April 1st, doctors basically got what we asked for. It will take a year before it goes into effect; however, insurance companies are required to offer plans that include OON benefits and they will be tied to the Fair Health rates. The companies also must tell what percentage of UCR they will cover. This is a huge win as the insurers were removing OON benefits from almost all benefit packages.


Included in the bill is the requirement that HMOs have adequate networks and if they don't then the patient can go out of network for appropriate care. Also an external appeal right to go OON will be established.

Also a mechanism of dealing with surprise bills by non par physicians for emergency care is established.

Medical Liability

Medical liability will be on the table again as the trial lawyers try to get their restrictive proposals passed.



For physicians with Office-Based Facilities there are some proposals to further regulate them. MSSNY is fighting to prevent the imposition of burdensome and unnecessary regulations on Office-Based Surgical Practices. We feel that the regulations we have now are good and that there is no need to change them.

I-Stop

Don't forget about the I-Stop law. As of August, 2013 you or a designee have a "duty to consult" the Prescription Monitoring Program (PMP) each time you issue a prescription for a schedule II, III, or IV drug. If you haven't done so yet, you can get an account at: https://hcsteamwork1.health.state.ny.us/pub/top. html. The next interesting wrinkle will be the mandated electronic prescribing effective March 27, 2015.

Please, continue to donate to MSSNY's PAC, as it works for all of the physicians in New York State and plastic surgeons have a large role in the leadership of MSSNY. The incoming president is a plastic surgeon practicing in Westchester, Andrew Kleinman MD. He takes office April 13th.
